Internal deviation reports include relevant information on the sample and sample processing, such as: the name of the person who registered the deviation, location, sample number, the customer's name and social security number, the time of sampling, information on the sample processing and analytics as well as information on the laboratory results and a note if there is need to correct the results. The respondent may give their name and contact details for prize draws.
6. Regular sources of data	The data in the personal data register is collected from customer feedback written by the customer themselves or reported by staff, internal deviation reports filed by staff and suggestions for improvement. Data is also collected through electronic customer and staff surveys.
7. Recipients of data	No data in the register is disclosed.
8. Transfer of data outside the EU or EEA	In principle, personal data in the register is not transferred outside the EU or EEA.
9. Retention period	The data collected in the register is stored only for as long as and to the extent necessary for the original or appropriate purposes for which the personal data was collected. Personal data referred to in this privacy policy is stored for as long as the data controller uses it for the purposes specified in section 4. Personal data stored in the register is erased when the legal basis for its processing ceases to apply.
10. Principles of protection	Appropriate technical and organisational measures have been taken to ensure the information security of the register and the confidentiality, integrity and accessibility of the personal data collected. Right to erasure The data subject shall have the right to obtain from the controller the (Article 17) erasure of personal data concerning them without undue delay if the personal data is no longer necessary in relation to the purposes for which it was collected or otherwise processed; the data subject withdraws their consent on which the processing is based, and where there is no other legal ground for the processing; the personal data has been unlawfully processed; or the personal data has to be erased for compliance with a legal obligation in Union or Member State law to which the controller is subject. The request to have data erased is submitted by sending a written request to the Data Protection Officer (tietosuoja@fimlab.fi).
